1. Introduction

The applicant for this Certificate may be the legal representative of any public or private entity (administration, organisation, institution, association, company, consortium, etc.) responsible for the management of the establishment requesting Starlight certification and with responsibility for the provision of information and the astronomical, tourist and/or cultural activities offered at the proposed Rural Hotel or House.

In accordance with the Procedure established for Certification, the first step is to complete the attached form (Application Pack), in which documentary evidence of the following points must be provided:

1. The applicant must have legal power to represent the establishment applying for Starlight Rural Hotel or House status.
2. The applicant or institution represented must formally adhere to the “La Palma Starlight Declaration” and declare its intention to fulfil and promote the general principles of sustainability.
3. The applicant must strictly comply with the conditions described in the procedure of the Starlight Certification System for Starlight Rural Hotels and Houses.
